To apply to Oxford Cultural Leaders you will need to complete an online form available at www.oxfordaspiremuseums.org/oxford-cultural-leaders. The application form is composed of seven sections, outlined below. This document provides a list of the questions on the form to assist you in preparing your application.

In addition to completing the form, we require a reference to be submitted on your behalf by your Director, line manager, colleagues, or a recent client, explaining why they think you would benefit from participating in the programme. This section asks for your contact details. It also provides the opportunity to upload your CV and provide additional information that may not be covered in the application form. We suggest you tailor your CV to your application and request that it consists of no more than 2 pages of A4 (210 x 297 mm). Only one attachment can be uploaded and it must be less than 2MB and formatted as a txt rtf pdf doc or docx.

- tell us about their relationship with you and outline how you will benefit from participating in the programme.

We will not share your application form with your sponsor but we do encourage you to discuss it with them at the time you submit it.
